ARTICLES & COPYRIGHT

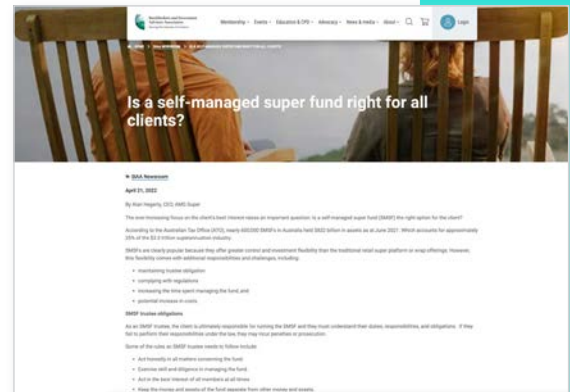
1. Articles should be a minimum of 600 words and a maximum of 1200 words, or as agreed with SIAA. Although not essential, if appropriate we encourage the inclusion of a chart or graph to support the article. Ideally, charts, graphs and images are to be supplied as separate files.
2. Ideally articles must be original and must not have been published previously or be under consideration by another publication. However, with prior agreement, previously published or previously published and updated articles will be accepted for the *Industry Insights*.
3. The article is to be attributed to an author with the byline to include the name, title and company.
4. Articles submitted must be the final copy, fully edited and proofed for grammar and concept and provided in word format.
5. Advertorial, commercial or promotional articles will not be accepted. While we appreciate articles on new ideas and investment opportunities, our readers wish to be educated, not sold.
6. We will publish articles by our sponsors, which may feature information about their products or investment opportunities. In such cases, the article will always be published as a 'Sponsored article', so that our readers are fully informed.
7. We will apply house style to the articles and will edit them to correct spelling, typographic and grammatical errors. We will contact you should more substantive editing be required.
